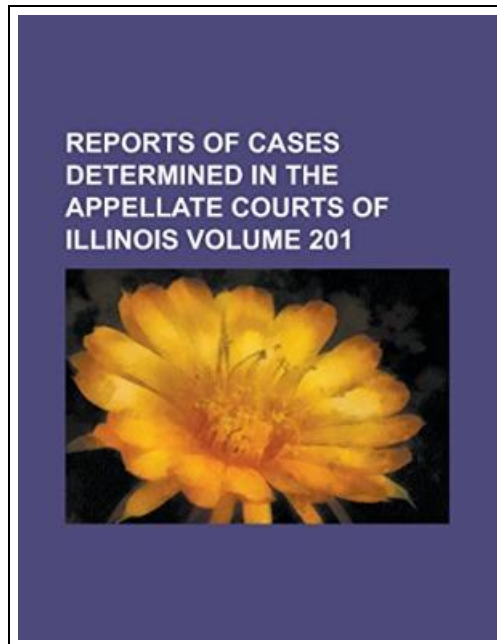

McCormick, who was the president, treasurer and general manager of the appellant, testified that the property taken in payment of \$19,900 of the stock consisted of 275 empty boxes, a typewriter, two or three boxes of soap, a barrel of metal polish, a wooden desk and \$125 of Iowa accounts, the entire property being worth not to exceed \$375. On June 8, 1913, as president of the corporation, he made a report in writing to R. G.
