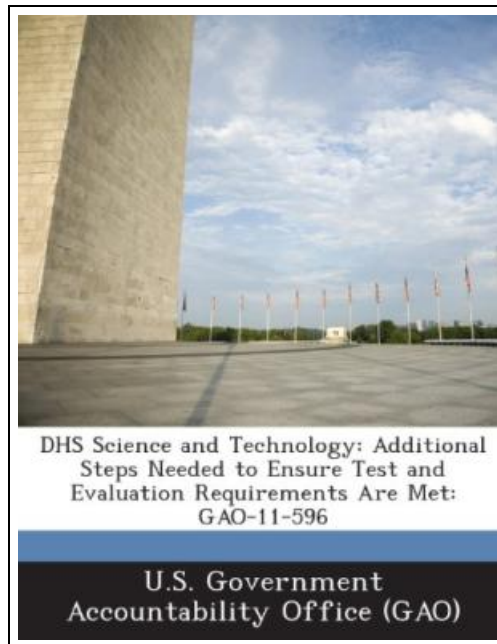

In 2009 and 2010 respectively, DHS issued new TE and acquisition directives to address these challenges. Under these directives, DHS Science and Technology Directorate s (ST) Test Evaluation and Standards Office (TES) is responsible for overseeing TE of DHS major acquisition programs--that is, those with over \$300 million in life-cycle costs--to ensure that TE and certain acquisitions requirements are met. GAO was asked to identify (1) the extent to which TES oversees TE of major acquisitions; and (2) what challenges, if any, TES officials report facing in overseeing TE across DHS components. GAO reviewed DHS directives and test plans, interviewed DHS officials, and reviewed TE documentation from a sample of 11 major acquisition programs from each of 11 different DHS components. The results of the sample cannot be generalized to all DHS programs, but provided insights.
