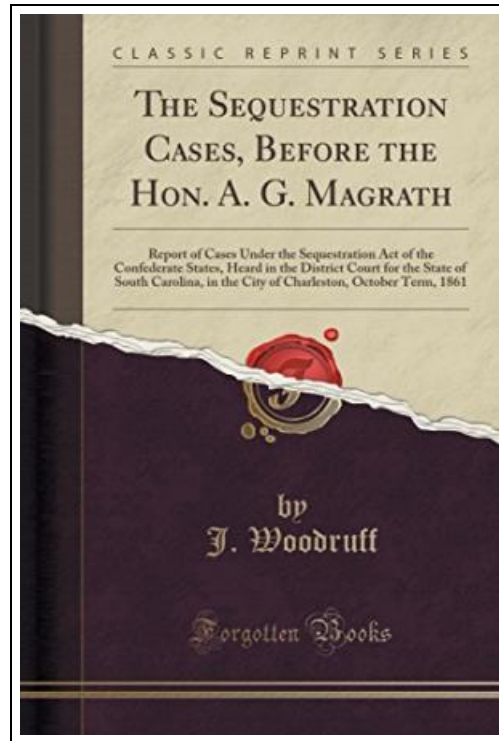

To depart from its limits. It has appeared necessary to the Congress of the Confederate States that it should exercise this right: and it has done so. In pursuance of its act, the President of the Confederate States has issued his proclamation requiring those who are citizens of the United States, and acknowledge its government; to depart from the Confederate States after the expiration of forty days from the date thereof The act provides that it shall be the duty of the several Courts of the Confederate States, and of each State, having criminal jurisdiction; upon complaint of such alien enemy, being resident or remaining within the Confederate States, contrary to the act and the proclamation of the President of Confederate States; to cause such alien to be apprehended: and after examination thereof, to order him removed from the territory of the Confederate States: or to be Otherwise dealt with or restrained; and to imprison or secure him until the order for his removal shall be prepared. The same act provides that during the existing war, citizens of the United States, who shall duly give notice of their intention to become citizens of the Confederate States, and acknowledge the government hereof; shall not be liable to be dealt With, as is provided for alien enemies The Act is of...
